## **ABWA Scholarship Opportunities**

The Stephen Bufton Memorial Education Fund (SBMEF) exists to provide educational grants and scholarships to women pursuing undergradudate and graduate degrees as well as ongoing professional development in order to support their career advancements and to help them become role models and leaders for the future.

#### National Awards

This year's national graduate awards are: \$10,000 Hilary A. Bufton, Jr. Scholarship for Finance; \$3,000 Glorine Tuohey Memorial Scholarship for

Nursing; and \$3,000 President's National Scholarship for Computer Science.

#### **Outright Grants**

Our Chapter will sponsor one applicant for a \$1500 SBMEF Outright grant award. Women with a 2.5 GPA or better at the sophomore level of a 4 year degree program may be eligible. Deadline is 4/15/2010.

#### Special Scholarship

A \$1000 award to a student in a licensed, accredited vocational technical school or community college authorized to confer associate degrees will be made this year. Deadline for applications is 5/15/2010.

### **Business Skills**

Tuition reimbursements up to \$500 for non-degree coursework to enhance career objectives are still available through our chapter. Multiple award to chapter members may be made.

## **Top Ten Business Women Judging Standards**

All national Top Ten candidates are judged in five areas according to the following point system:

- Personal Goals: Personal and professional goals two to five years out, how ABWA has helped you achieve your goals, what you've done to fulfill ABWA's mission. 10 points.
- ABWA Historical Profile: Involvement in ABWA activities.

offices, events or programs, number of members sponsored. 10 points.

- Formal Education: Accredited or continuing education completed. 5 points
- Career Accomplishments: A resume format that describes the progression of the candidate's career. 20 points
- 5. Community Involvement: A description

of what the candidate has give back to her community. 5 points.

The maximum number of points a member can receive is 50.

Candidates are female, employed, a current or past chapter officer, has been an ABWA member in good standing for at least three years as of May15 and has been a primary member of this chapter for at least one year as of May 15.

Brief description of the roles of Chapter Officers:

Treasurer: Responsible for the financial records. Obtains signature cards for new Chapter officers. Issues payments for events, scholarship, SBMEF contribution, annual dues to National. Collects dues/payments. Balance checkbook and funds monthly. Issues financial report monthly.

Secretary: Responsible for the record-keeping. Submits minutes of Executive Board meeting within three (3) days after meeting to President. Submits minutes of Chapter meeting within five (5) days after meeting to members. Submit minutes/report/tally info within five (5) days after election to National. Membership reporting to national, guest follow up, perfect attendance records.

## **Other Committee Roles & Descriptions**

**Auditing:** Audit treasurer's accounts.

Fund-raising: Present recommendations for projects that will provide sufficient funds for the chapter that should be used to support the chapter's goals. (The goals for the chapters are to increase the business efficiency of all members; improve the earning power of all members; promote good relations between employers and employees; assist members in securing employments; advance members in a social, business and educational way: and assist women in the community to better themselves through professional development.)

Hospitality: Responsible for reservations, food, and other special arrangements for meetings. RSVP list and on-line Evite program. Bring pens, invocation/benediction sheets, raffle basket & tickets, get validation

stamp, bring guest checkin list, guest name badges, members name badges, collect \$ for meeting, raffles, total and provide \$ and list to Treasurer. Provide copy of guest list to President and Secretary.

Membership: (Enrollment) Encourage membership retention and promote membership recruitment either in its chapter or in the formation of a new chapter. Maintain an accurate chapter roster and report all status, name, email and address changes to the secretary of ABWA National. Cross reference information on the WIN site. Assist the vice president in performing her duties as chapter

Newsletter: Publish a chapter newsletter, at least six times a year coordinate its distribution. Announce the time and place of the next meeting, stimulate interest In upcoming speakers and chapter projects, encourage attendance, introduce new members, recognize accomplishments of members, streamline meetings, reports, agendas, and other information that allow members to come prepared to vote. Serve as a networking tool, involve business through advertising, include list of Committee Chairs and contact information.

**Nominating:** Present slate of officers to members.

Professional Development: (Member Ed, Scholarship, Community Service) Review the professional development programming at ABWA spring & national conferences with the membership.

Program: (Hospitality, Business Associate, International Theme Night, Progressive Dinner) Survey members annually to determine areas of busi-

Survey members annually to determine areas of business interest. Compiles and reports survey results to Executive Board. Makes recommendation on business and market relevant program topics. Plan, select and schedule professional development programs/speakers for chapter meetings and other special events as requested. Introduce guest speakers. Responsible for planning the time, place, reservations, food and other special arrangements needs for meetings or events.

Publicity: (Website)
Send promotional information to all appropriate media covering national, chapter and member achievements as well as chapter activities. Attract prospective members, reinforce present membership, generate corporate support, build ABWA awareness in the community.
